Introduction of new BIA Board members Meredith Chatelain and Nathan Wilcox.

Discussion with Jay Slaven re: effect downtown Strathroy 2 hour parking restriction has on business es. There are several business in the downtown area that are affected by the two hour parking restriction. In regards to Blackgate Tattoo, many client appointments vary from 3 hours up to 8 hours. Clients cannot leave during procedure to move cars. There are 5 plus similar shops in the core area. Appointment length in excess of two hours is common to many personal care providers, and also applies to retail/restaurant patrons looking for an option that provides a longer experience. The current situation requires 2 hour curbside parking OR parking in a municipal lot. However, the municipal lots are also encouraged for downtown tenants and business staff. Quite often the lots can be full for afternoon parking. The best empty lot would be by the train tracks. This is a fair distance from the core retail spaces. Jay requested support from the BIA to gather support from BIA Business member to devise a solution and deliver it to council. The most cost effective solution proposal involves the Municipality having available "extended parking pass" plaques that a business could give to their client to identify that the vehicle owner is currently involved in an activity that requires more than the current two hour limitation. The BIA Board agrees with Jay's initiative and would support this request to Council that an option to extend two hour parking in the core area would be beneficial to BIA Member businesses.
